- (b) DIN is mandatory for anyone intending to become a company director.

Step 3: Reserve a Unique Company Name

- (a) File the Name Reservation application (RUN form) on the MCA Portal.
- (b) Choose a unique and meaningful name that complies with the naming guidelines and isn't already taken.

Step 4: Draft Memorandum and Articles of Association (MoA & AoA)

- (a) Draft the MoA and AoA defining the company's objectives, rules, and internal structure.
- (b) These documents are essential for incorporation.

Step 5: File Incorporation Application (SPICe+ Form)

Submit the SPICe+ (INC-32) form along with:

- (a) MoA (INC-33)
- (b) AoA (INC-34)
- (c) PAN and Aadhar of directors
- (d) Proof of registered office address
- (e) Utility bills (not older than 2 months)
- (f) Pay the prescribed registration fee and stamp duty.

Step 6: Obtain Certificate of Incorporation

- (a) Once documents are verified, the Registrar of Companies (ROC) will issue a Certificate of Incorporation (COI).
- (b) This certificate contains your company's Corporate Identity Number (CIN) and marks the legal birth of your company.

Post-Incorporation Compliances

After incorporation, complete these essential formalities:

- (a) Apply for Permanent Account Number (PAN) and Tax Deduction and Collection Account Number (TAN).
- (b) Open a current bank account in the company's name.
- (c) Register for Goods & Services Tax (GST) if applicable.
- (d) Maintain statutory registers, records, and file annual returns regularly.
